**“IKEEPSAFE – INTERNET SAFETY”**

This presentation is about the benefits and risks experienced by users of the world wide web either via computers or by cell phones or online gaming or other personal data devices.

The Attorney General offers advice to parents on how you can help your children (and yourselves) benefit from the wealth of information and opportunity that the Internet provides while remaining aware of the very real risks of exposure to other Internet users who have criminal or devious intentions.
